## Overview of Investor KITAS C313(1 yr.), C314(2 yr.) with your own PMA

### Purpose

The Investor KITAS is designed for foreign nationals investing in Indonesia. C313 is for investments under IDR 10 billion, and C314 is for investments over IDR 10 billion.

### Validity

C313 is valid for 1 year, while C314 has a 2-year validity.

### Extension Possibility

C313 can be extended yearly, and C314 can be renewed after 2 years.

A foreign national who has resided in Indonesia for a minimum of five consecutive years with a KITAS is eligible to apply for a KITAP visa.

### Applicable Activities

Suitable for business activities related to the investor's venture in Indonesia.

## Essential Documentation

### From the Applicant:

- **Bali Visa Application Form**  
Complete the form in full.
- **Passport Scans**  
Provide color scans of the identity and signature pages of your passport (no photos required, only scans).
- **Passport Validity and Blank Pages**  
Your passport should have a minimum validity of 20 months for a 1-year visa, and 32 months for a 2-year visa, with at least 2 blank pages.
- **Digital Passport Photo**  
A recent passport-style color photo in digital format.

➤ **Bank Statement**

A statement showing at least USD 2,000 in your account.

## **From the Company (PMA - Foreign Investment Company):**

➤ **PMA Company's Official Documents**

This includes all formal documents related to the company's legal status.

➤ **Establishment Deed and Amendments**

The original document establishing the company, along with any changes made later.

➤ **Ministry of Law and Human Rights Approval**

A document showing the company's authorization by the MoLHR.

➤ **Company's Tax Registration Number (NPWP)**

The official tax identification number of the company.

➤ **Online Single Submission (OSS) Documents**

This encompasses the Business Identification Number (NIB), Location Permit (Ijin Lokasi), and Business License (Ijin Usaha).

➤ **Shareholders' Identification**

Copies of foreign shareholders' passports or Indonesian ID cards (KTP) for Indonesian shareholders.

➤ **Company's Letterhead and Stamp**

Used for formal business communication.

## **Processing**

➤ **SCAN OF PASSPORT/PHOTO OF PASSPORT**

- Submit a scanned image of the passport details page and cover.
- Passport must be valid for a minimum of 7 months from the entry date.

➤ **FORMAL FOTO**

- Provide a formal passport-style photo.

➤ **RETURN FLIGHT TICKET**

- Include a flight ticket demonstrating your departure from Indonesia before the visa expiration date (if applicable).

➤ **ADDRESS IN INDONESIA**

- Indicate your accommodation details in Indonesia, such as Hotel, Villa, or House (if applicable).

## Visa Extensions information

B211A Offshore Visas will be able to be extended only 2 times the maximum, each extension will be for 60 days.

This visa can't be extended beyond 180 days.
